Medicare Part B Special Enrollment Period

Note: During the Alumni planning breakfast in January, Chuck Toner advised the group of the information that follows. We asked him to please provide the info in the newsletter to share with the rest of our members. Thanks Chuck.

President Bush recently signed a bill that introduces an outpatient prescription drug benefit. This does not

affect uniformed services beneficiaries. as their Tricare pharmacy benefits will continue as a separate program. However, the bill also makes three very important changes relating to enrollment in Medicare Part B. (the supplementary medical insurance program). The first affect persons two changes enrolled, or paying surcharges because they enrolled after they were initially eligible for Part B. The third affects income of seniors. First, uniformed services beneficiaries who would be eligible for Tricare for Life, but are not enrolled in Medicare Part B May now enroll without penalty during a special enrollment period starting on a date vet to be determined through December 31, 2004. This special enrollment period will be announced on the Tricare Website, Second, uniformed services beneficiaries who did enroll in Medicare Part B in 2001, 2002, 2003 or 2004 and are subject to a premium surcharge for late enrollment in Part B can get those surcharges eliminated by demonstrating that they are covered under Tricare. The elimination of surcharges is effective January 1, 2004, but the procedures still have to be worked out and will be announced on the Tricare Third, all seniors, not just Website. uniformed services beneficiaries are affected by this change. The Part B premium will be tied to income, beginning in 2007. Individuals with incomes above \$80,000 will pay more. couples with incomes above and \$160,000 will pay more. 
Jack,
